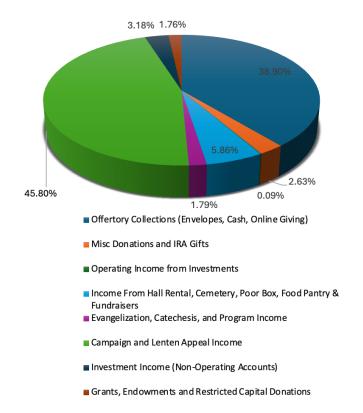

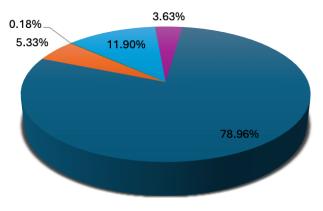
TOTAL INCOME (2024-2025)



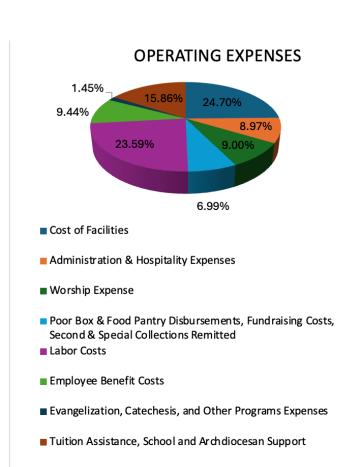
TOTAL EXPENSES (2024-2025)
