### TERMS AND CONDITIONS

**Reservations & Payments:** A deposit of \$500 min per person (check or M.O.) and a signed Passenger Reservation Form Contract are required to secure a reservation. However, an initial deposit payment with a check or Zelle transfer will be accepted in lieu of a signed contract and constitutes that the participant acknowledges that he has read, understood, and accepted the terms stated in the contract and agrees to be bound by them. Reservations are taken on a first come/first served basis. Full payment is due not later than **75 days (April 3, 2024)** prior to departure. Reservations may be cancelled, and we reserve the right to levy cancellation charges as stated in these conditions if full payment is not received 75 days before departure.

**Rooms:** Prices are based on double occupancy. You may be required to pay the single room supplement if a compatible roommate is not available. Triple room may be necessary with no cost reduction.

**Tips and Service Charges:** Tips and gratuities are not included in the price. The recommended tipping for good service is \$6-\$7 per day to the tour escort/guide and \$5-\$6 to the motorcoach driver per day. Local guide: \$4 per day.

**Trip Cancellations: (It is highly recommended to purchase travel insurance to cover the cost in case of unexpected emergencies)** Cancellation schedule: 100 or more days prior to departure, \$400 penalty, 75-100 days prior to departure, 50% of tour cost; 75 days before the trip, 100% of cost. Cancellation must be in writing.

**Luggage:** You are limited to **only one (1)** full size luggage, max 50lbs and 1 **small hand carry, to be carried to the bus seat.**

**Tour Responsibilities:** Universal Tours, Inc, the local land operators arranging for all matters pertaining to hotel accommodations, sightseeing tours and transportation will not be responsible for any damage, expense or inconvenience caused by air, rail, ship or bus arrivals or departures or by any change in schedule or other conditions, nor will they be responsible for the loss or damage of baggage or any article belonging to the passenger. The participant agrees that Universal Tours, Inc., the local land operators, coordinators, and promoters shall not be liable for damages and losses (including personal injuries, deaths, and property losses) or expenses occasioned by acts of omissions of any person, including suppliers providing services, for any acts of war, insurrection, revolts, or other civil.

Promoters and coordinators are not agents or authorized representative of Universal Tours and the local operators. All voucher and other documents for

services issued are subject to the terms and conditions specified by the suppliers and to the laws of the country where services are supplied. If there are any changes in the itinerary for reasons beyond the control of the local operators, it will arrange for provisions of comparable services. Any resulting additional expense will be payable by the participant. The local operator reserves the right to decline or accept or retain any person as participant, to make changes in their itinerary whenever the company deems it necessary to the comfort, convenience, and safety of the pilgrim participants, and to cancel a pilgrimage at any time. **A minimum number of 40 paying passengers per bus are required to maintain the offered price (Price adjustment will be announced).** No person other than authorized representative of Universal Tours and the land operator is authorized to vary, add, or waive any term or condition in this brochure, including the terms and conditions set forth in the foregoing provisions. **All published fares and prices are based on the exchange rates quoted at the time of publication (current Israeli Shekel rate as of Sept 2023) for this specific tour and could change at any time. Airfare prices due to fuel cost fluctuations may vary until paid and ticketed.** Universal Tours, Inc. and its representatives, the pilgrimage tour coordinators, and tour promoters assume no liability in the land arrangements such as transportation, hotels, and other accommodations. By participating in this tour, you are bound by the rules of the tour operator. All airlines' rules and regulations must be followed. After the airline ticket is issued, the participant is bound by the rules of the airline carrier. **The participant is participating in any activities of the tour at his/her own risks.** When children or minors are present, it is the parent or designated guardian's responsibility to look after the minor's safety.
